



ST JULIANS CLUB HOUSE RULES

The House Rules have evolved over the years since the Club's formation in 1956 from a combination of the needs of members and Rumshott Estate Limited. They, together with the rules relating to the Club registration, premises licence and Rumshott Estate's Health and Safety documentation, constitute the rules by which people must conduct themselves while visiting St Julians.

GUESTS Members may introduce and entertain friends at the Club and there is a visitors book kept at the Club in which both the member and their friend/s must sign. The member introducing a visitor must accompany him and is responsible for his visitor strictly observing the Club rules. The Club Committee may suspend any member who takes any undue advantage of this privilege. The Visitors' Book is available in the main hall outside the bar. For guests to the bar and restaurant under normal circumstances six guests are permitted per adult member.

Only Full and Country members may bring guests for swimming and tennis – for which there is a charge. Further information overleaf.

The same guest may not visit St Julians Club in any capacity (i.e swimming, tennis or social) more than four times in any one period of twelve months. To do so will be in breach of the Club Rules.

SOCIAL MEMBERS Social membership is for the use of the bar and restaurant only. Social members are not entitled to use the swimming pools and tennis courts, buy guests tickets for the use of these facilities, allow their guests to use these facilities, or to be within the fenced pool area.

CHILDREN Children of members or of guests are not the responsibility of Rumshott Estate Limited or the Club Committee of St Julians Club. Members are responsible at all times for the conduct of their children and child guests.

All people under the age of 16 must be accompanied by a member over the age of 18. Children included in a family membership aged between 16 and 18 may come unaccompanied to St Julians on the understanding that the House Rules shall be respected. Children under the age of 18 are not permitted to bring guests to the club, whether socially or to use the pools and / or tennis courts.

Children included in a Family membership aged under 16 and guests under 18 must be supervised by an adult when visiting any part of the Club, and the adults are requested to be mindful of their children's behaviour.

CLOSING TIME The Club premises will normally close at 11.00pm on Monday to Saturday and at 10:00pm on Sunday. They may be kept open later for functions or closed earlier at the discretion of Rumshott Estate Ltd. Please call before you come if you think this could be the case.

DOGS **NO DOGS** at all, please, in any part of the grounds including in cars and the car park.

DRESS Please dress appropriately on the premises; this also applies to children. In other words no bathing costumes in the public areas of the house or immediately adjacent to the house. In the interests of safety please wear shoes or sandals when you are within the licensed areas: in the house, bar lawn, terrace and upper lawn.

GAMES Ball games may be played in the area designated beyond the sandpit. Please respect other members and we ask that members do not play ball games in any areas where people are relaxing in the grounds.

LOST PROPERTY We regret we cannot take responsibility for property lost but valuable items, if found, will be stored in the reception office for collection.

PARKING Please do not park in the circle. This obstructs emergency services such as fire engines and ambulances. If you park at the top of the upper car parks please leave your car in gear. Please leave the parking area closest to the house for disabled badge holders.

PICNICS Members may not picnic on the terrace, bar lawns or in the house, but are welcome to do so elsewhere in our grounds. BBQs are not permitted. Glasses, bottles and crockery are not permitted beyond the bar lawns and terrace. Plastic glasses and disposable plates are available from the bar.

SWIMMING POOL The swimming pools are totally unsupervised. Although fenced, the pool area is accessible. Members are particularly reminded that their children **MUST** be supervised at all times when in the grounds with particular attention given to this area. There is further information for Full and Country members overleaf.

TENNIS Members are reminded that soft tennis shoes and appropriate dress must be worn; the rules with regard to booking courts and late arrivals are displayed by the booking sheet, and listed overleaf.

HEALTH & SAFETY Accidents, incidents or near misses must be reported to Reception during office hours or to any member of staff on duty during the evening or weekend. First aid kits are located at the following places: Kiosk, Bar, Kitchen and Reception. There are staff members qualified in first aid on hand at all times.

RADIOS You are not permitted to play amplified music at St Julians (ipod, radios etc). Amplified music may be played if you are holding a function where this has been previously arranged.

SMOKING As a family club we request that you smoke **ONLY** in the designated smoking area which is the car park end of terrace and car park itself.

CONDUCT Please be respectful of other member's personal space and be mindful of other members when taking photos or videos at the Club. Please also be respectful towards the staff at St Julians Club. When leaving the Club at night, please leave quietly as we have residents living upstairs and near neighbours who we do not wish to disturb. If you encounter any problem with the conduct of anyone at St Julians please contact a member of staff or the Club Committee.

FURTHER INFORMATION FOR FULL AND COUNTRY MEMBERS

GUESTS for SWIMMING and / or TENNIS

For use of the swimming pool and/or tennis courts, three guests are permitted per adult member. There is a fee for use of these facilities, which is £10 per guest age 3 years and over. All guests within the fenced swimming pool area, whether swimming or not, require a valid guest ticket. Members are required to buy guest tickets from the bar or office upon arrival to the Club or, if present, from a staff member at the top of the steps leading down to the pools.

SWIMMING POOLS

St Julians DOES NOT provide lifeguards. In case of emergency please use the phone by the pool to summon assistance.

For your own safety, please read the pool rules signs located in the pool area prior to swimming. Please also take notice of the pool depth markings. We recommend you do not swim alone or immediately following a meal.

No member under 16 may swim or be in the swimming pool area without the supervision of an adult member, who must take responsibility for their conduct and safety. Do not drop your children off at St Julians for an unsupervised swim.

Guests under 18 must be supervised by an adult member.

Any unsupervised child found in the pool area or in the pools will be asked to leave.

The pool is open from April until October. Regular hours are as follows, any amendments will be on the sign at the top of the pool steps: April & October 7am to dusk. May to September 6:30am – 10pm. The swimming pool area is out of bounds outside opening hours.

Diving is not permitted in the shallow end of the main pool for safety reasons. Diving is forbidden in the smaller pools.

Non-swimmers and learners must be supervised by a responsible adult and may only use the shallow end of the main swimming pool.

For your own safety and that of other members and guests, please refrain from running and jumping around the pool.

Balls are not permitted in the swimming pools. In the interests of safety and comfort of all members, you are requested to not play ball games in the swimming pool area.

Lilos, flippers and similar articles are not allowed in the pool. Only non-swimmers are allowed inflatables to assist with their swimming.

No-one may indulge in such activities as pushing or throwing others into the water, ducking or similar horse-play in or around the pool; no 'bombing'.

Again for your own safety, do not consume alcohol in the pool area. Do not swim while intoxicated. Glasses, bottles and crockery are not permitted outside the licensed area: this is within the house, bar lawn, terrace and upper lawn. Alcoholic drinks bought at the Club may be consumed within the licensed area. The swimming pool area is entirely non-smoking.

TENNIS RULES

The club committee has formulated a set of rules governing the use of the tennis courts. These are set out below, but members are advised that the rules should be obeyed not only in their letter but also in their spirit.

Nobody may play singles for more than 1 hour or doubles for more than 2 hours in any one session (irrespective of the person booking the court). However, this rule is not applicable if the court is NOT booked for the succeeding hour and/or no-one is waiting or subsequently arrives and wishes to play.

If a booking is not taken up within 10 minutes of the time reserved, the booking lapses and the court becomes available to the first member claiming it.

If members are waiting to use a court they must make themselves known to the players already on the court.

During weekdays (*Monday – Friday*) no member (or guest) shall play on more than two evenings in any week during the period 6.00 to 9.00 p.m.

Guests may only use the courts while playing with or against members. Members are responsible for paying the guest fee prior to playing: **summer guest fee** for swimming and/ or tennis of £10 per person (*1 April – 31 October*), **winter tennis guest fee** of £5 per guest (*1 November – 31 March only*). No guest shall play tennis more than 4 times in any year.

All players using the courts shall wear appropriate dress and footwear. Trainers are not suitable. Please wear tennis shoes or plimsolls only.

Members are reminded that bookings and cancellations by telephone should be made during ordinary office hours.

Members who have booked courts and subsequently do not intend to use them are urged to ensure they are cancelled promptly in order that other members may know that the courts are available for use.
